Certificate in Foundations of Political Theory

This certificate is a means of enhancing undergraduate education through a focused combination of courses, independent study, and program participation. Administered by the Political Science Department, the program is open to all Texas A&M University undergraduates, regardless of major.

If you are interested in gaining background for post-graduate studies in law, social science, history, or political theory, or for a fulfilling career that builds on your analytical and expressive skills, this certificate program may be for you.

The program requires 18 hours of course work, including an introductory course in political theory and a capstone senior research course. It also requires frequent participation in program activities such as lectures and conferences. Participants in the certificate program may choose one of two areas of concentration: history of political theory, or analytic political theory.

Interested students are encouraged to enroll in the program as freshmen to avoid having to add extra hours to the degree program. Students are encouraged to meet with the undergraduate advisor as early as possible to plan their courses of study and to make sure that they have completed the appropriate prerequisite courses.

Successful completion of the program will be indicated on the student's transcript. Each student will also receive a program certificate upon graduation from Texas A&M.

- 18 credits -- Introduction to Political Theory (POLS 303) + 4 upper division courses, including two required and two elective courses, from one of the lists below + a capstone course (POLS 481)
- participation in program activities, documented at least four times
- foreign language training recommended but not required

Capstone Research Experience (3 credit hours)

The capstone course is POLS481 – Senior Research Seminar. Since POLS481 is a variable content course, the student must be careful to choose a section for which the focus will be an original research paper independently developed by the student that explores historical or analytical political theory. (The student should consult with an academic advisor in Political Science to make certain that a particular section of POLS481 will apply for this certificate program.)

Conference and Lecture Participation Requirement:

Students are required to attend at least four of the lectures and/or conferences offered by the Program in Political Theory. Lectures are offered at least three times per semester, and conferences at least once per year. Students may choose any four of the lectures to fulfill this requirement, but are advised to start early. Certification that a student has attended a lecture requires two steps: (1) signing the sign-up sheet at the lecture site and (2) turning in a one-page, typed summary of the lecture to the Undergraduate Programs Office (UPO) in the Department of Political Science. The summary must be filed with the UPO within fourteen days after the lecture.

Admission Requirements

Admission requirements are identical to those listed under the Bachelor's degree in the Texas A&M University undergraduate catalog.

Although language training is not required for certification, successful completion of some senior research experience topics may depend on appropriate linguistic skills. Students are encouraged to acquire these skills early in their academic careers, and to meet with political theory faculty for advice on these matters.

Students interested in the Certificate should make an appointment with an academic advisor in the Undergraduate Programs Office (UPO) in the Department of Political Science, Allen Building, Room 2024.

Steps to Receive the Certificate in Foundations of Political Theory

- 1. Apply for the program as early as your freshman year or first year at Texas A&M University. Contact the Office of Undergraduate Advising in the Department of Political Science.
- 2. Plan ahead to schedule appropriate classes. You are responsible for acquiring the specific course work. UPO advisors are available to assist you in planning a program for completing Certificate requirements.
- 3. File for the Certificate during your semester of graduation. Download the document from http://www-polisci.tamu.edu/ or obtain a copy from the UPO, 2024 Allen Building. Submit the completed form to the UPO. You will receive the Certificate in six to eight weeks after graduation.
